## FUND OBJECTIVE

The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

- Actively managed to aim to deliver security, liquidity and attractive cash yields comparable to short-dated money market interest rates
- Daily liquidity with one day's notice
- Aims to add value with money market instruments collateralised by UK gilts, with counterparties including PPF eligible pension schemes as well as banks
- Fitch rated AA Af/S1, Moody's rated Aaa-mf
- Qualifying Money Market Fund (QMMF) for regulated Client Money. Investors should make their own independent determination as to whether the Fund meets the QMMF criteria before investing

## FUND MANAGER COMMENTS

UK annual inflation fell to 10.1% in March from 10.4% in February, with food price rises still the biggest driving force in the rise. Annual core inflation remained unchanged at 6.2%. The Manufacturing Purchasing Managers' Index fell to an estimated 46.6 from a reading of 47.9 in March, the ninth consecutive month of contraction, however, UK consumer confidence continued to climb in April, reaching the highest level since February 2022. In markets, SONIA remained at 4.18%, while the 2-year gilt yield increased from 3.42% to 3.78% and the 5-year gilt yield rose from 3.32% to 3.60%. With the increased expectation of rate rises, Fund activity was centred around positioning for central bank meetings. The weighted average maturity of the Fund was 13 days at the end of March and 11 days at the end of April.

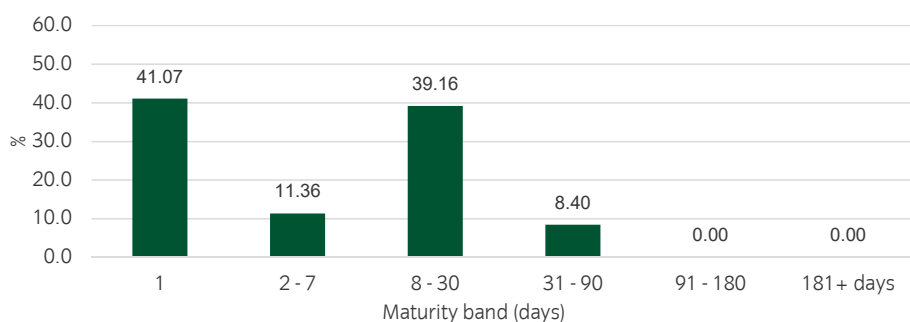

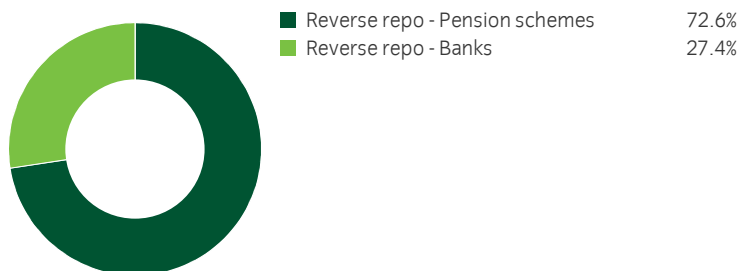
