The Fund seeks to maintain the principal of the Fund and to provide shareholders with daily liquidity with an income which is comparable to sterling denominated short dated money market interest rates

FUND MANAGER COMMENTS

Annual inflation in the UK remained unchanged at 6.7% in September, as slowing food price rises were offset by rising petrol costs. The manufacturing purchasing managers' index rose from 44.3 in September to 44.8 in October. The services purchasing managers' index increased slightly to 49.5 in October from 49.3. In markets, SONIA remained unchanged at 5.19%, while the 2-year gilt yield declined from 4.89% to 4.77% and the 5-year gilt yield decreased from 4.50% to 4.46%. Fund activity was centred around positioning for central bank meetings. The weighted average maturity of the Fund was 15 days at the end of September and 16 days at the end of October.

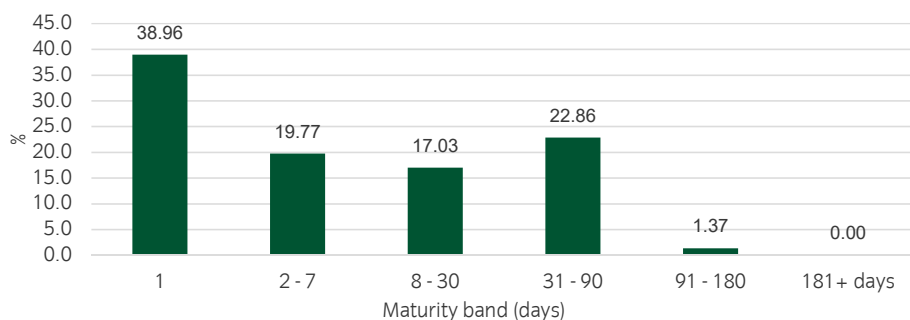

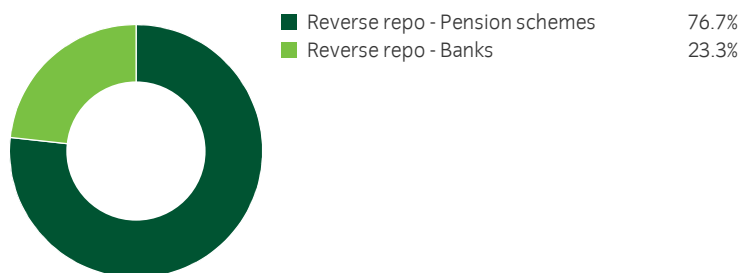
