FUND MANAGER COMMENTS

The Fund generated a positive return in May. Risk free assets were volatile, while credit spreads tightened. The Fund's long credit positioning was positive. Our long positions in loans and asset-backed securities contributed. Our relative value credit positions were positive, as the performance of our euro-denominated assets offset losses from our position in cash versus credit default swaps. Country selection was beneficial, driven by our long position in South Korea relative to the US and Japan. The Fund's duration positioning was positive, due to our short position in Japan. We increased our long duration position in the US and took profits from the exposure. The Fund's inflation positioning contributed to performance. Yield curve positioning was positive, as our steeper positions in the US and Germany contributed. Our emerging market positions were neutral. Currency positioning contributed, as the US dollar underperformed the euro as well as the Australian and Canadian dollars.

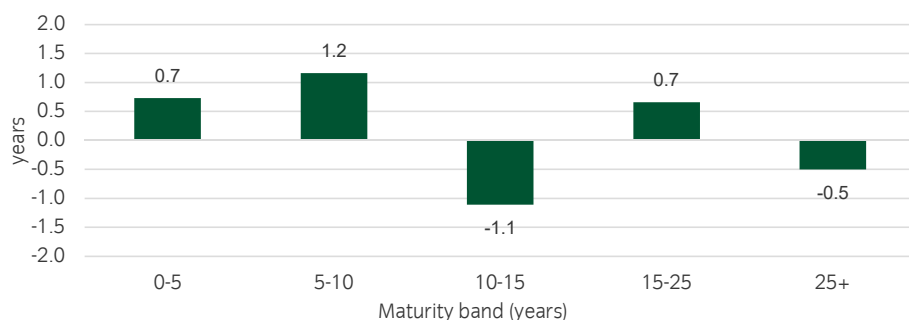

DURATION EXPOSURE BY MATURITY

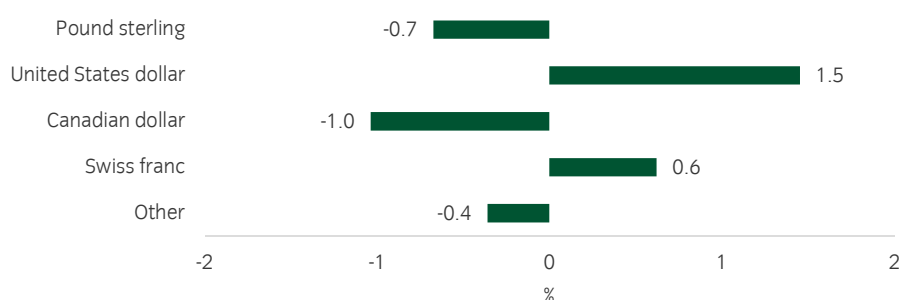
