## FUND MANAGER COMMENTS

The Fund generated a negative return in May. Risk free assets posted losses due to concerns around US fiscal policy. Our long corporate credit position was a negative, while long positions in asset-backed securities contributed. Our relative value positions had a mixed effect. Euro-denominated assets underperformed their US dollar-denominated peers, while credit default swaps outperformed cash. Duration positioning was a negative due to our positioning in core markets, as yields rose. Yield curve positioning detracted, driven by our flattener positions in Japan and our steepener position in the US. Intra-Europe country selection had a neutral impact. Our cross-market positioning worked well due to our positions in Brazil and New Zealand relative to US Treasuries. Inflation positions were a positive, resulting from our positioning in US inflation relative to European inflation. Currency positioning detracted, driven by our long positions in the Australian dollar, the euro and the yen.



## DURATION EXPOSURE BY MATURITY


