FUND MANAGER COMMENTS

The Fund's performance was solid in July, as it continued to outperform the cash benchmark on a year-to-date basis. In July, leveraged loans posted gains against slowing primary issuance and robust collateralised loan obligation activity. Over the month, key contributors included Valeo, ZPG, TK Elevator, Parts Holding Europe and a Term Loan B financing from Motor Fuel Group. The European default ratio remained at 1.3%. Over the month, total loan volumes fell to €3.7 billion in July from €15.4 billion in June. Year-to-date, loan issuance reached €70.7 billion, compared to €24.5 billion in the equivalent period in 2023. We expect the default ratio to reach around 3.75% in 2024. We continue to focus on companies with strong cash flow and believe that skilful stock selection will help investors capture the full coupon while avoiding defaults. Leveraged loans are still supported by strong technical factors and investor inflows driven by higher coupons.

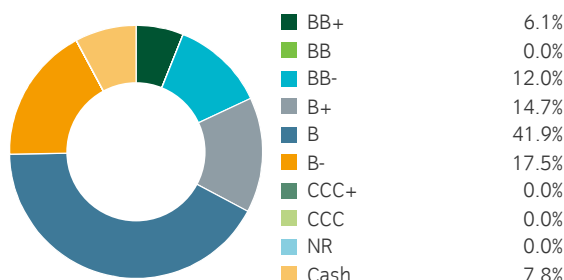

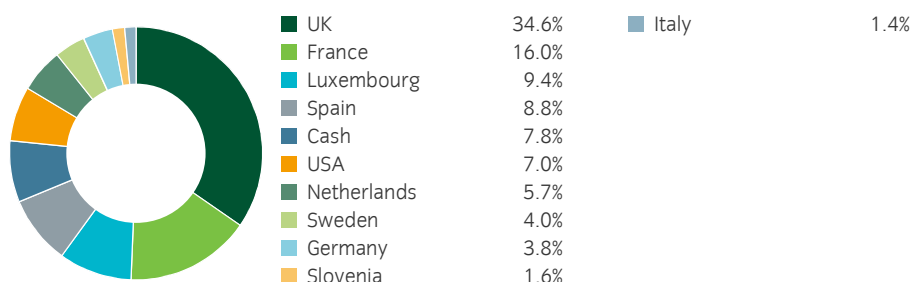

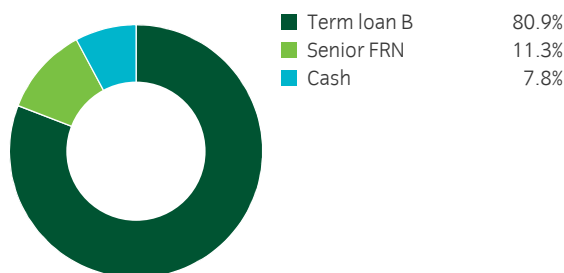
GEOGRAPHY
