
FUND MANAGER COMMENTS

The Fund maintained its positive performance and continues to outperform the cash benchmark on a year-to-date basis. In August, leveraged loans posted gains, despite market volatility and investor outflows. Over the month, key contributors included Valeo, Zoopla, Vodafone Spain and a Term Loan B financing from Motor Fuel Group. The European default ratio remained at 0.8%, while the distress ratio decreased from 3.02% in July to 2.80% in August. Over the month, total new loan volumes were just €100 million. Year-to-date loan issuance reached €70.8 billion, compared to €25.5 billion for the equivalent period in 2023. We expect defaults to reach around 3.75% in 2024. We continue to focus on companies with strong cash flow and believe that skilful security selection will help investors collect the entire coupon while avoiding defaults. Leveraged loans are still supported by strong technicals. As interest rates decline, companies may switch from the loan market to the bond market.




GEOGRAPHY
