FUND MANAGER COMMENTS

The eurozone annual inflation rate declined to 5.3% in July from 5.5% in June, due to falling energy prices and a slower rate of food price increases. The European Central Bank raised interest rates by 25bp in July, leaving the main refinancing operations rate at 4.25%, the marginal lending facility at 4.50% and the deposit facility rate at 3.75%. The eurozone economy expanded by 0.3% in the second quarter, according to a preliminary estimate, after a 0.1% contraction in the prior quarter. In markets, 1-month EURIBOR rose from 3.39% to 3.58% over July, while the 3-month rate increased from 3.58% to 3.71%. We bought floating-rate notes from Toronto-Dominion Bank. We will continue to position for further central bank rate hikes, with risks around the stickiness of inflation. The weighted average maturity of the Fund was and 85 days at the end of June and 58 days at the end of July.

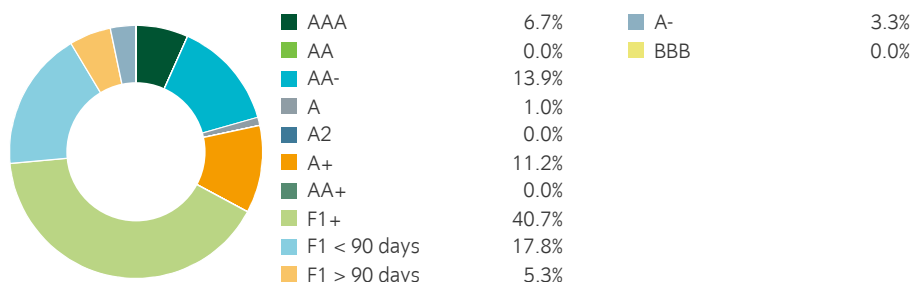

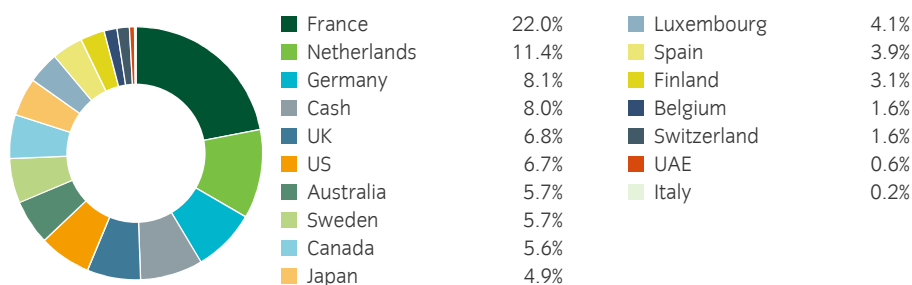

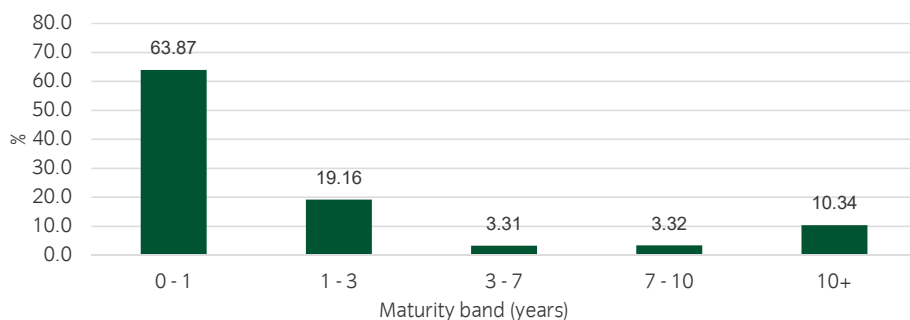

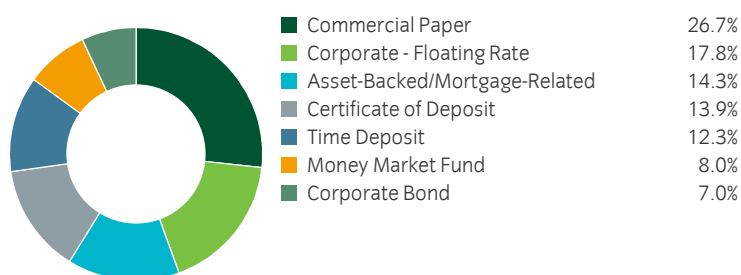
GEOGRAPHY
