FUND MANAGER COMMENTS

Eurozone inflation crept up to 2.9% in December from 2.4% in November; food and service price rises had the biggest impact. The European Central Bank left interest rates unchanged at its January meeting. The eurozone economy stagnated in the fourth quarter of 2023, according to a flash estimate. The Eurozone Manufacturing PMI increased to 46.6 in January from 44.4 in December. In markets, 1-month EURIBOR rose from 3.84% to 3.88% over January, while the 3-month rate remained at 3.90%. We bought floating-rate notes from FCDQ, Société Générale, Hiltermann Lease and Nordea. While the inflation outlook appears positive and markets are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity was 60 days at the end of December and 60 days at the end of January.

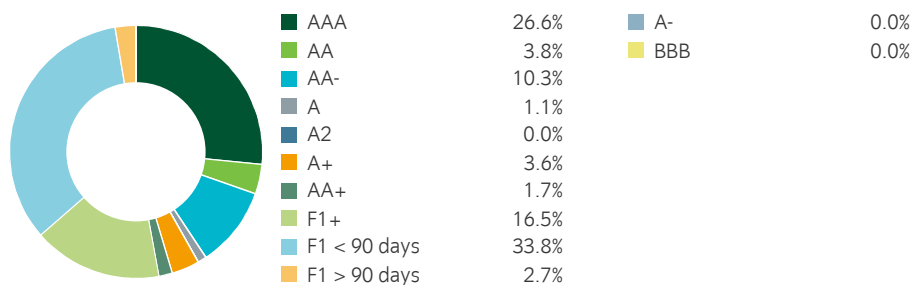

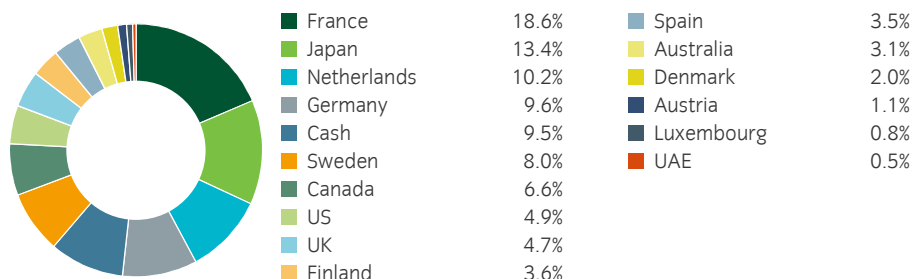

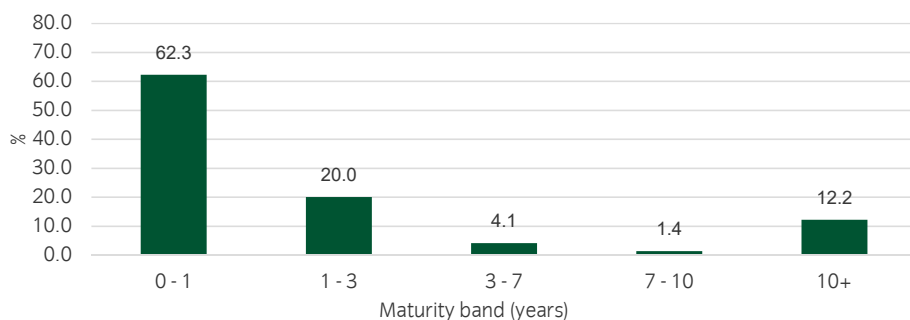

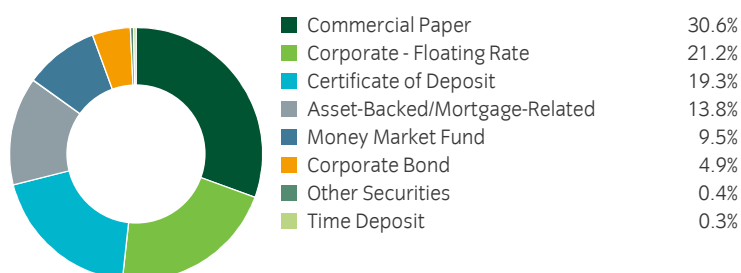
GEOGRAPHY
