FUND MANAGER COMMENTS

Annual inflation declined by 10bp to 2.8% in January, with core inflation falling to 3.3%. The Manufacturing Purchasing Managers' Index edged down from 46.6 in January to 46.5 in February, with Germany's weak economy constituting the main drag. The Services Purchasing Managers' Index increased from 48.4 in January to 50.2 in February. In markets, 1-month EURIBOR fell from 3.88% to 3.86% over January, while the 3-month rate rose from 3.90% to 3.93%. We sold certificates of deposit and commercial paper from Lloyds Bank. We bought floating-rate notes from ANZ. Positioning will be determined by upcoming central bank meetings. The weighted average maturity was 60 days at the end of January and 68 days at the end of February.

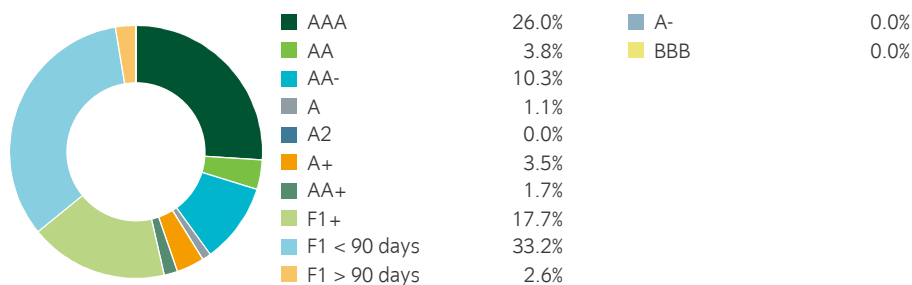

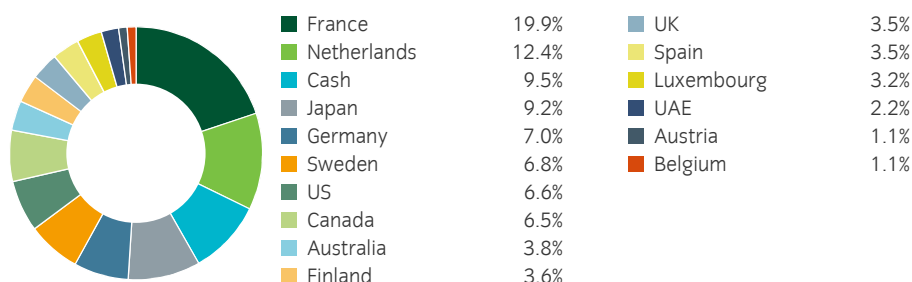

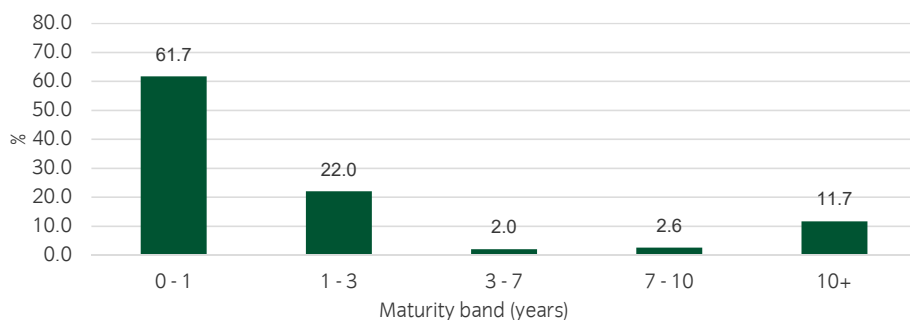

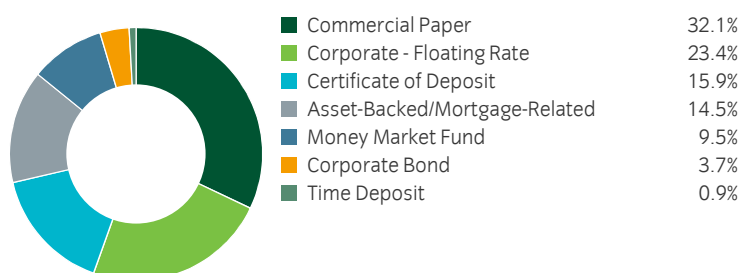
GEOGRAPHY
