## FUND MANAGER COMMENTS

There were mixed signals for cash markets in October. The Labour government's first Budget announced around £40 billion in tax rises, alongside increased borrowing to boost growth, but was greeted negatively by markets. The Manufacturing Purchasing Managers' Index declined from 51.5 in September to 49.9 in October. However, annual inflation fell by 50bp to 1.7% in September and the unemployment rate fell by 10bp to 4.0% in the three months to August. In markets, SONIA remained at 4.95%, the 2-year gilt yield rose from 3.95% to 4.36% and the 5-year gilt yield increased from 3.81% to 4.31%. We bought certificates of deposit and commercial paper from First Abu Dhabi Bank, United Overseas Bank, DNB, Swedbank, Nordea, Deka, ACOSS, CDC, Santander and EAA, among others. We bought bonds and floating-rate notes from National Australia Bank, Commonwealth Bank of Australia, and Handelsbanken. The weighted average maturity of the Fund was 35 days at the end of September and 34 days at the end of October

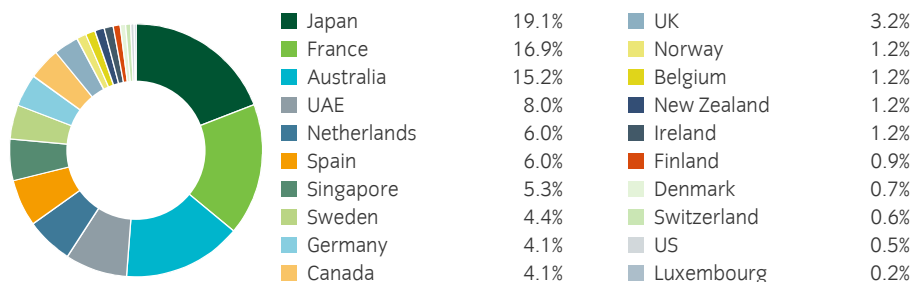

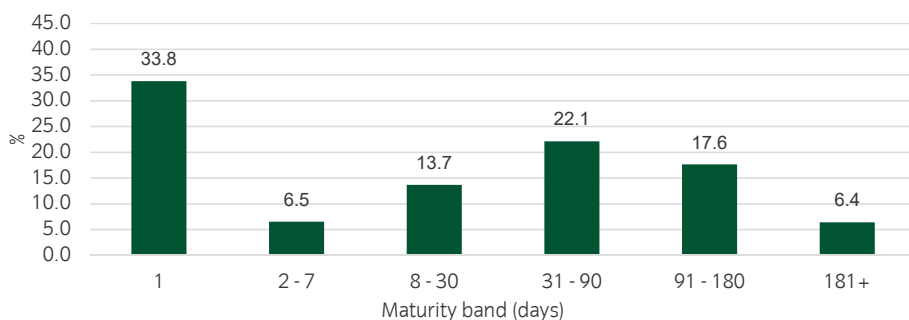

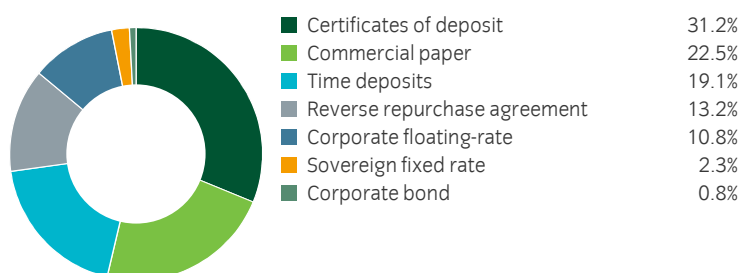
