FUND MANAGER COMMENTS

The annual inflation rate saw its second monthly fall to 2.6% in March, which has helped increase speculation of an interest rate cut in early May. The Manufacturing Purchasing Managers' Index increased from 44.9 in March to 45.4 in April, while the Services Purchasing Managers' Index declined sharply from 52.5 in March to 48.9 in April. The unemployment rate remained at 4.4% in the three months to February. In markets, SONIA remained at 4.45%, the 2-year gilt yield fell from 4.20% to 3.80% and the 5-year gilt yield decreased from 4.29% to 3.92%. We bought certificates of deposit and commercial paper from First Abu Dhabi Bank and J.P. Morgan. Notable transactions included purchases of bonds and floating-rate notes issued by Bank of Montreal and Commonwealth Bank of Australia.








GEOGRAPHY
