## FUND MANAGER COMMENTS

Annual inflation in the US rose to 3.2% in July from 3% in June largely due to an increase in the price of transportation services. Conversely, annual core inflation declined by 10 basis points to 4.7%. The US economy expanded at an annualised rate of 2.1% in the second quarter; a 30-basis-point decrease from the preliminary estimate. The manufacturing purchasing managers' index declined to 47.9 in August from 49 in July. In markets, the Secured Overnight Financing Rate remained unchanged at 5.31%. Fund activity was centred around positioning for central bank meetings. We will continue to position for further central bank rate hikes, with risks around the stickiness of inflation. The weighted average maturity of the Fund was 13 days at the end of July and 22 days at the end of August.

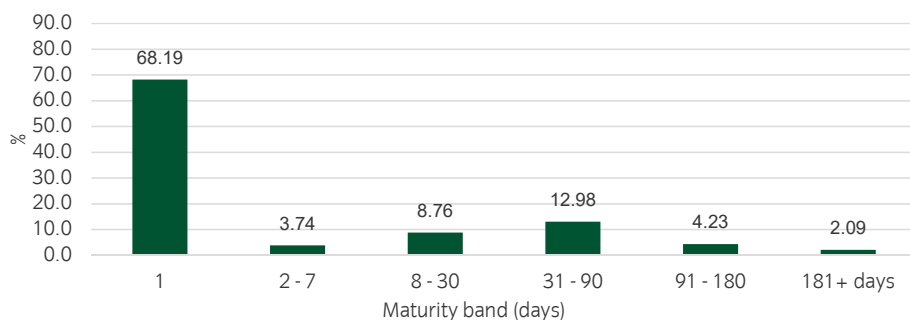

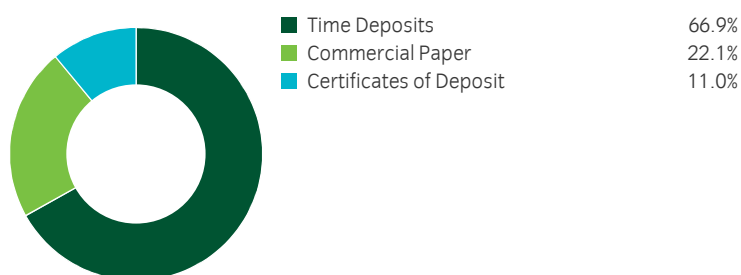
