## FUND MANAGER COMMENTS

US annual inflation rose from 3.2% in February to 3.5% in March. The Manufacturing Purchasing Managers' Index fell from 51.9 in March to 50.0 in April and the Services Purchasing Managers' Index fell from 51.7 to 51.3. Unemployment edged lower by 10 basis points to 3.8% in March. In markets, the Secured Overnight Financing Rate rose marginally from 5.32% to 5.34%. While the inflation outlook appears positive and investors are pricing in no further rate hikes, selective term investments were favoured. Positioning will be determined by upcoming central bank meetings. The weighted average maturity of the Fund was 23 days at the end of March and 20 days at the end of April.

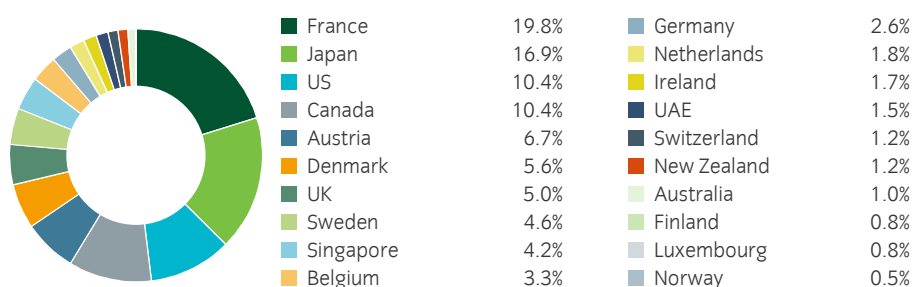

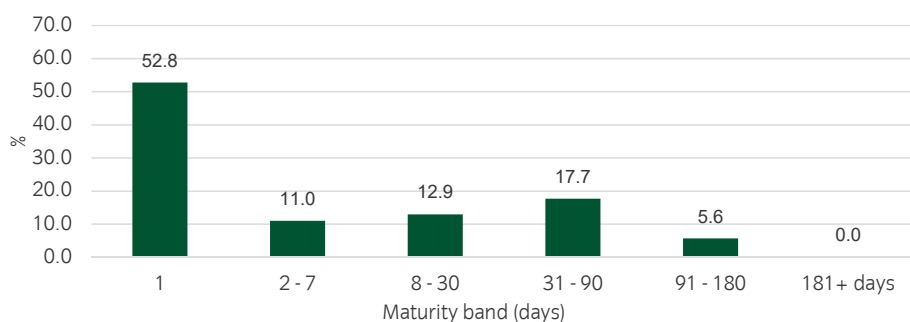

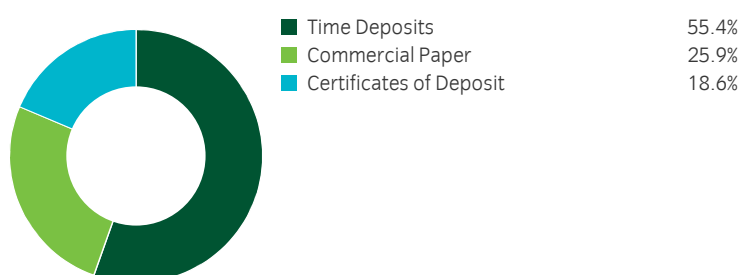
