## FUND OBJECTIVE

The Fund seeks to generate a return for investors mainly through investment in a portfolio of liquid asset backed securities (ABS) and corporate floating rate notes (FRNs)

- Aims to add value principally through a focus on daily liquidity management, via a high allocation to AAA and AA rated instruments with short maturities

## FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in March, ending with a running yield of 75bp ahead of one-month SONIA and a 98% weighting to AAA rated assets. Risk assets posted gains. European structured credit performed well. Despite elevated valuations, relative value versus corporate credit remains attractive, but the prospects of tightening have diminished. Issuance was robust, led by residential mortgage-backed securities (RMBS) and collateralised loan obligations. The best-performing assets remain within the bottom tranches of investment grade. US structured credit posted gains, against elevated issuance and strong demand. Spread tightening in AAA rated assets was marginal, while spreads within mezzanine paper tightened more meaningfully. In our view, investor demand and attractive relative value should lead to further tightening, especially in esoteric sectors. Performance was driven by carry and spread tightening within Australian RMBS.

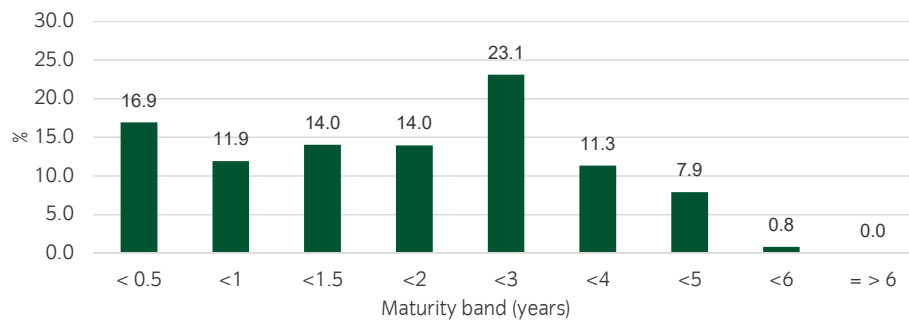

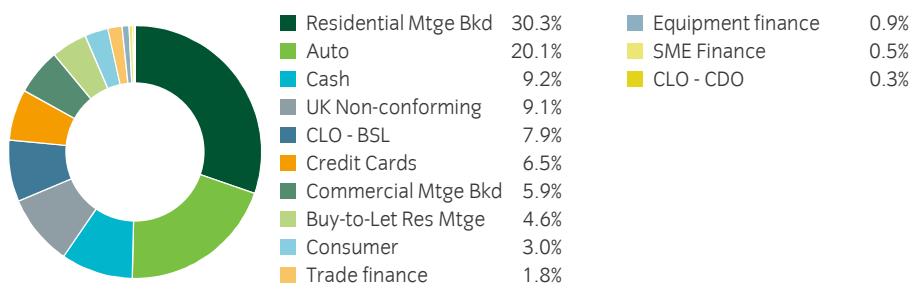
