FUND OBJECTIVE

The Fund seeks to generate a return for investors mainly through investment in a portfolio of liquid asset backed securities (ABS) and corporate floating rate notes (FRNs)

- Actively managed to aim to deliver positive absolute returns in excess of a cash benchmark
- Aims to add value principally through a focus on daily liquidity management, via a high allocation to AAA and AA rated instruments with short maturities

FUND MANAGER COMMENTS

The Fund outperformed its cash benchmark in April, ending with a running yield of 71bp ahead of one-month SONIA and a 98% weighting to AAA rated assets. Risk assets sold off due to persistent inflation. In contrast, European structured credit performed reasonably well. Despite elevated valuations on a historical basis, relative value versus corporate credit remains inexpensive. Absolute yields in BBB rated collateralised loan obligations appear attractive. The month saw robust issuance from several sectors and jurisdictions. US structured credit was mixed, despite elevated issuance and strong demand. Spreads within prime automotive tightened, while those in the subprime space widened. Consumer delinquencies continue to rise but at a slower pace. Asset-backed securities (ABS) are insulated from further deterioration. Performance was driven by carry. Investment activity focused on automotive ABS and front pay tranches of Australian residential mortgage-backed securities.

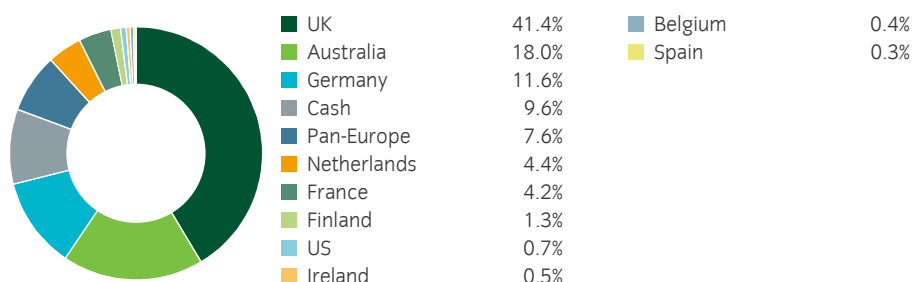

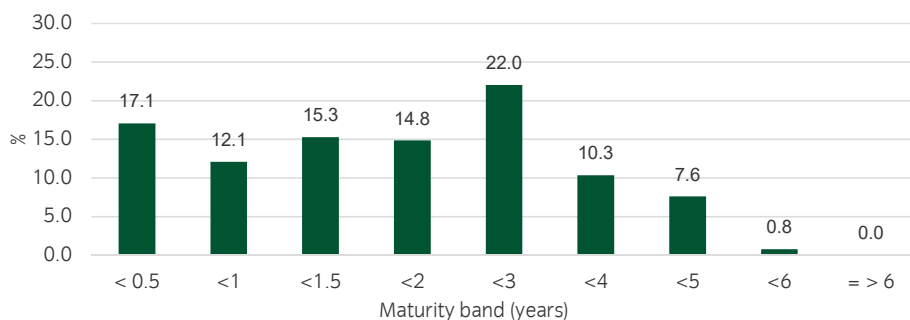

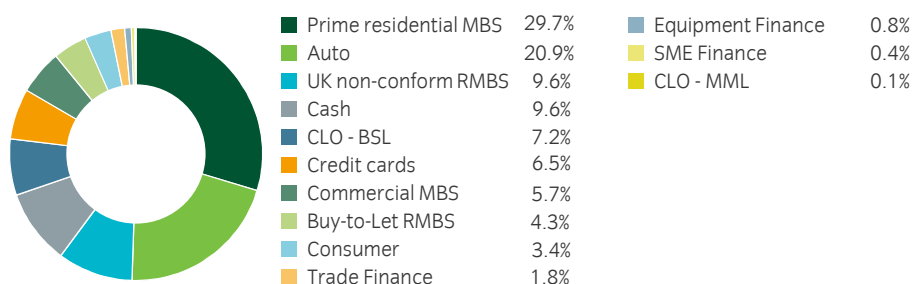
